PETITION

FOR PROCEEDINGS PURSUANT TO THE CORTESE-KNOX-HERTZBERG

LOCAL GOVERNMENT REORGANIZATION ACT OF 2000

The undersigned hereby petition the Local Agency Formation Commission of Monterey County for approval of a proposed change of organization or reorganization, and stipulate as follows:

- 1. This proposal is made pursuant to Part 3, Division 3, Title 5 of the California Government Code, commencing with Section 56000, Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.
- 2. The specific change of organization proposed is:

Detachment of approximately 3,742 acres from the Monterey Peninsula Water Management District (the "District"), and corresponding amendment to the District's sphere of influence.

The subject territory is served by the Cañada Woods Water Company (the "Water Company"), a privately owned public utility providing comprehensive water supply, water reclamation and wastewater treatment services to area residents and landowners.

- 3. The boundaries of the territory included in the proposal are as described and illustrated in **Exhibit A**, attached hereto and by this reference incorporated herein.
- 4. The territory included in the proposal is:

- 5. This proposal is consistent with the District's sphere of influence, because a request for an amendment to the District's sphere is included with this petition.
- 6. The reasons for the proposed boundary change are as follows:

To avoid duplication of community services and to provide for more efficient and economical, domestic water and wastewater services management, as envisioned under the Cortese-Knox-Hertzberg Act of 2000, Cal. Government Code § 56000, et seq.

Please see Statement of Justification attached hereto as Exhibit B.

The subject territory is occupied by the Monterra and Tehāma (formerly, Cañada Woods, Cañada Woods East and Cañada Woods North) subdivisions. (See Exhibit C-1, attached hereto.) These projects were approved by the Board of Supervisors over a span of several years and the Board's Resolutions of Approval are attached hereto as Exhibits C-2 through C-7.

The Water Company operates under a Certificate of Public Convenience and Necessity issued by the California Public Utilities Commission ("CPUC") (Decision No. 02-04-006, April 4, 2002). A copy of the CPUC's decision and order is attached hereto as **Exhibit D**. The CPUC's order authorizes Cañada Woods Water Company to merge the Cañada Woods Treatment Company and the Monterra Ranch Mutual Water Company. One privately owned public utility will now provide water, sewer and reclaimed water service to both Monterra and Tehāma subdivisions. A service plan is attached hereto as **Exhibit E**.
