Greetings,

I'm writing to engage Monterey peninsula water supply and pollution prevention agencies to sponsor bilingual Green Gardener classes on the Monterey peninsula this spring. In the fall, we conducted a survey of improvements and topics that public agency sponsors and Green Gardener alumni wanted to see in future courses. From this evaluation process, we are proposing a series 6 Saturday courses that include Green Landscape Design, Sustainable Hardscapes and Stormwater Management, Turf Removal Strategies/Water-wise Plant Selection, Drip Irrigation System Design and Maintenance, IPM for Vertebrates and Enhanced Biological Control, and Laundry to Landscape Graywater Systems.

This year, we have BWET grant funding to incorporate hands-on learning activities in Green Gardener classes with a student installation of a water-wise demonstration landscape at the Monterey Peninsula Unified School District office in downtown Monterey. The grant provides more than \$10,000 in materials and staff time to promote the class and pay the landscape contractor (Central Coast Wilds) to design and assist with installation of the training landscape. The district is also providing a big match of time to assist with the site preparation, class promotion and registration services.

Even after all this good news, if we fail to secure local agency support, the classes will not happen. Futhermore, NOAA has just announced that the BWET grant for adults will not be renewed in 2012. It really is up to the community to keep the Green Gardener program going. Thankfully, Santa Cruz County water agencies and City and County stormwater divisions in public works have collectively committed \$14,000 to offer Green Gardener certification courses in Santa Cruz County in 2011 and beyond. I'm hoping Monterey County can keep the regional program strong to build on public education successes should IRWMP or other grant opportunities present themselves in the future.

The excel worksheet attached has two tabs that represent a budget and course outline. I've broken down the budget between Monterey Peninsula Water Management District and Monterey Regional Water Pollution Control Agency. The budget and course outline are negotiable to meet your needs, but please keep in mind that critical items are guest speakers and spanish interpretation if you want the class to be bilingual. Unfortunately I don't think we can afford to have a separate class for our Spanish speakers.
