# Pure Water Monterey Expansion

- Pure Water Monterey Expansion provides a permanent replacement water supply
- PWM anticipated to be on-line in 4<sup>th</sup> quarter 2025
- Ordinance No. 196 allocates a portion of the additional new water supply (371 AF) amongst the Jurisdictions in the MPWMD
- Maintains remainder in District Reserve

## **Determination of Allocations**

#### Factors considered when determining allocations

- Historical average water consumption by Jurisdiction
- Total waters supplies available
- 25-year growth rate (water demand) by Jurisdiction using AMBAG 2022 Regional Growth Forecast
  - Population growth = Future Residential water use
  - Job growth = Future Non-Residential water use
- Survey of future needs for MPAD and Department of Defense sites
- Adjustments for 6<sup>th</sup> Cycle Regional Housing Needs Allocation (RHNA)

## Ordinance

- In addition to the Jurisdictional Allocations:
  - Amendment to Rule 31 to require monthly Allocation Report to Board
  - Explains allocation methodology
  - Maintains unused Jurisdictional Allocations as of the effective date
  - Effective date March 1, 2025
  - Adds review requirement at least every four years following AMBAG Regional Growth Forecast or more frequently if needed

## Jurisdiction and Committee Review

- District GM met with representatives from each Jurisdiction
- Presentations to each governing body and Dept. of Defense representatives
- Water Demand Committee reviewed 12/5/24 and recommended the ordinance to the Board

# California Environmental Quality Act Review

- District authorized literature review for appropriate environmental action for allocation process
- RINCON 2023 Technical Memorandum concluded:
  - The proposed water allocation qualifies as a project under CEQA
  - The Pure Water Monterey 2021 Supplemental EIR (SEIR) had already analyzed the growth-inducing and secondary environmental effects associated with the proposed water allocation
  - Based on those findings, RINCON prepared an Addendum to the SEIR
  - MPWMD Board of Directors adopted in February 2024

### Recommendation

- The Board should conduct a public hearing before consideration of first reading
- Staff recommends the Board move Ordinance No. 196
  to second reading and consideration of adoption at the
  January meeting with the following amendment:
  - Delete the sentence in Section Four that says, "Future allocation of water may occur by resolution of the Board of Directors."
     Future allocations should occur by ordinance
