


# U.S. Occupancy is Back to Pre-COVID Level

## National Travel Indicators & Forecasts

#### **U.S. Hotel Forecast**

While 2024 U.S. hotel occupancy has not returned to 2019 levels, average daily rates are more than 20% higher. With this, RevPAR for the year is expected to end 16% higher than in 2019. This 3% year-over-lift is due primarily to continued increase in rates.

For the coming year, occupancy is expected to reach pre-COVID levels for the first time at a national level. Combined with continued increases in rates, total RevPAR is expected to be 19% across the U.S. in 2025.


# California Lags by 6% v. Pre-COVID

#### **California Visitor Forecast**


While hotel occupancy across the U.S. is anticipated to be off just 1% for calendar year 2024, Tourism Economics forecasts the state of California will see visitor volume 6% lower than pre-COVID levels. While other destinations have been able to overcome continued declines in volume through price increases, California's visitor spending is not anticipated to meet or exceed the 2019 baseline until 2027.



# Monterey Occupancy Off 8% from Pre-COVID

## Monterey County Travel Indicators & Forecasts


### Monterey County Hotel Forecast

While Monterey's hotel recovery remains below the U.S. average, it is exceeding California's performance overall. For the calendar year, Monterey's occupancy is 8% off that of 2019, while California's occupancy is 13% lower. While the state's ADR has increased 12%, Monterey's is 26% higher. Overall, Monterey's 2024 RevPAR is expected to be 17% higher than in 2019, exceeding the U.S. average of 16%. For 2025, there is little change expected in occupancy. However, rates will continue to rise and produce a 24% higher RevPAR than pre-COVID.

# Monterey Occupancy Pre-COVID was Near-Full


## Monterey's pre-pandemic occupancy rate was nearing full capacity.

This section reviews ways to increase the economic impact of tourism given current supply constraints

While a 73% occupancy rate may leave an impression that there are numerous available rooms, this is close to full capacity for a leisure destination. It is rare to see non-urban destinations (cities fill weekdays and 'low' seasons with business travelers) maintain annual occupancy rates above 75%.

Therefore, increasing the economic impact of tourism in Monterey County largely depends on some combination of increasing room inventory, increasing visitor spending per booked room, and filling out the shoulder periods (especially weekdays).

## **Occupancy Rates Vary by Season**

## MCCVB is also well-positioned to increase off-season bookings.

While Monterey's 73% annual occupancy rate is quite high for a non-urban leisure destination, MCCVB can realize the opportunity to increase low-season bookings.

If the six low-season months (average occupancy 64%) matched the occupancy rate of the six high-seasons months (80%), Monterey would see an increase of 354,000 rooms booked—a 10% increase over its current total.

# **AMBAG Engaged Jurisdictions**

### Section 1: Process for Forecast Completion

Following the preparation of the regional forecast figures, AMBAG staff began the process of disaggregating the figures to each of the jurisdictions using historical data to develop a baseline disaggregated forecast. The initial results were a purely quantitative application of the methodology. These preliminary draft disaggregated numbers were presented for discussion purposes at one-on-one meetings held by AMBAG staff with each of the jurisdictions, the Local Agency Formation Commissions, the Fort Ord Reuse Authority, the University of California, Santa Cruz and the California State University, Monterey Bay. AMBAG staff also provided materials for these meetings that outlining the data sources and methodology for the regional forecast figures as well as the preliminary draft disaggregated forecast figures. The intent of the first round of meetings was to gather information and data that was then used to make adjustments to the forecast. (See Attachment 1 for a list of meeting dates, times and attendees.)

These preliminary draft disaggregated numbers were adjusted based on information and feedback provided by each jurisdiction. In addition, new data became available. The release of vintage 2020 estimates from the California Department of Finance showed 2019 population approximately 7,000 lower than in the preliminary estimate, although housing estimates were relatively stable. These updates necessitated minor revisions to the regional forecast.

Staff updated the regional growth forecast to reflect the most current information. The entire revised forecast, regional and subregional, was re-circulated for a second round of comments. After the second round of comments were received, AMBAG staff incorporated additional input and prepared a revised draft of the disaggregated forecast figures. Staff circulated the revised population, employment and housing forecast which incorporated additional comments from the Board of Directors. The final draft was accepted for planning purposes only by the AMBAG Board of Directors at its meeting on November 18, 2020. The final growth forecast is scheduled for adoption along with the 2045 Metropolitan Transportation Plan/Sustainable Communities in June 2022.


